STURGIS OR BUST

Two months of planning, several weeks of 10-12 hour days, praying for product to be delivered in time to load the trailer and we are ready to head north. Three 400-mile days on two (and three) wheels in thunder storms seems par for the course on any 21-day adventure, but none-the-less brutal. Although, the 20 mph crosswinds on the way home were pretty taxing on these old bones, too! Not really sure which was tougher – rain or wind?! No matter what, the joys and freedom of the road are worth every drenching / windblown moment!

But, is there a secret to finding 93-octane fuel outside of Texas? Best we found, after departing our dearly, beloved State, was 91... I don't know about your bike, but neither of ours care much for anything less than 93! Spoiled babies? Indeed! *(continued on pg 7)*



Legislative Report



Our Texas 87th general legislative session is all but history – with the exception of the 1st and 2nd Special Sessions that Governor Abbott called. If the Texas Democrats don't come back from DC soon, Gov. Abbott promised that he would call for a 3rd special session – all funded with your tax dollars. What a mess!

Let's recap what motorcycle bills advanced during the 87th regular legislative session. Two House bills that Texas motorcycle advocates fought for had advanced through their entire chamber (well, HB 1838 did). HB 1838, relating to "intelligence

databases for combinations & criminal street gangs" (gang database reform) made it through the full House and was received by the Senate. This bill received a 121-22 vote on the House floor, but we simply ran out of time to advance anything in the Senate. Another bill advancing through the House chamber was HB 1837 - relating to "motorcycle profiling by peace officers". This bill was certain to advance, and we were already hopeful that Texas may become the 5th State in the Country to pass a law addressing unlawful profiling by police officers - but again, we simply ran out of time.

As you know, Texas legislature only convenes in odd numbered years (2021); and then, the regular session only lasts 140 days. IMO, this is barely enough time to advance a bill through both chambers, especially if the bills are somewhat "controversial". After the end of each session, we should analyze what we did right, and what we can improve on for next session. One thing that we learned this session is that every day is valuable. With no days to spare, we need to work each bill, every day, as if it were the last!

Let's take a look at our profiling bill, which made it as far as it could in the House – almost getting a vote on the full House floor. Remember, we only have 140 days. To begin, we had to wait **27 days** to get this bill filed (even though we were looking for a bill number from day 1) – this made for a bad start, and it only got worse from there. After HB 1837 was read the first time, it took **20 days** for this bill to be scheduled for a public hearing. A few committee members found some of

the language "controversial", which they told us at the hearing. It was left pending in the committee for **9 days**, and then it was considered again in a formal hearing. Again, it was left pending - for **27 days!** During these 27 days we requested a CQ "Take Action" link from the MRF, and we posted and shared that link on Facebook; Texas bikers took action in a big way! In 2 days, the House had substituted the "controversial" language with something more to their liking and considered it (for the 3rd time) in a public hearing; and this time it was reported favorably (as substituted). In the following 3 days, HB 1837 received a unanimous committee vote of 9 ayes and 0 nays – and 1 day later this bill was sent to the Calendar Committee to be placed on the calendar for a general House vote. That was on May 8th, and May 10th was the last day that the House could report on House bills! If HB 1837 could have been placed on the calendar only a few days sooner, the Senate could have received this profiling bill. Looking back at the timeline, you start thinking "wow, how could we have saved a couple of days here, or there". That's why I say, work your bills every day, as time is of essence!

We are optimistic that similar bills, to HB 1837 & 38, will have a 60% greater chance of becoming law during the next legislative session. It was, in many ways, a historic session for Texas motorcycle legislation; and we definitely learned a lot – I just hope we remember what we learned for 2023!

Many of us are returning from Sturgis this week (as I write this), including many from Texas! I got the opportunity

to see friends and Motorcycle Riders Foundation members, at the "Whitewood Social" - hosted by ABATE of SD. Hardtail briefed us all on the Senate version of the Transportation bill, and how important it is to keep the MAC (Motorcycle Advisory Council) in the Senate version of the Transportation Bill; also important are autonomous vehicle testing requirements that must prove testing includes motorcycles. The best outcome would be the merging of the two chamber versions into one, which would allow for favorable House motorcycle language. Thank you for the hospitality, ABATE of SD! Congratulations to Deborah Butitta, board member of the Motorcycle Riders Foundation, for being inducted into the 2021 Sturgis Hall of Fame. Deborah was the recipient of the "Freedom Fighter Award", which recognizes individuals who have made

a long-term impact on the motorcycle rights community. We also got a free fill-up at the "Chip" with 93-octane, 10% ethanol, gasoline; in South Dakota ethanol gasoline is a good thing, and 93-octane is a rare find.



I hope many MRF members, and non-members alike, are making plans for the 37th Annual "Meeting of the Minds" in Atlanta, GA, September 23rd-26th. This will be the 1st time that the MOTM will be held in Georgia – and it promises to be historic!

Also, don't forget that Texas ABATE is hosting the 29th Annual Mid-South M.I.L.E. in Dallas, TX, October 22-24th. The M.I.L.E. (Motorcyclists Improving Legislative Effectiveness) is a regional event with six States participating – Arkansas, Kansas, Missouri, Oklahoma, Louisiana, and Texas. We are grateful to Louisiana – for

organizing a fundraiser for this event, and for donating the proceeds (over \$2,000) to Texas ABATE for the 29th Annual Mid-South M.I.L.E. The sessions are all new, including new guest speakers - make your plans and your reservations now to join us on October 22nd – 24th, 2021!

June to September are the peak months for motorcycle crashes – don't become a statistic. Remember, nearly 'half of all motorcycle crashes are single-vehicle accidents (motorcycle only); take your time and arrive alive! I hope to see y'all soon!

ROADMAP'S RUN RULES

8. Stopping: Fuel, Food, Breakdowns, Law Enforcement, Crashes
 - a. Fuel
 - i. Everyone should know BEFOREHAND when a stop for fuel will be coming up. NO ONE should run out.
 - ii. EVERYONE tops off. NO ONE should run out.
 - iii. Maximum fifteen (15) minutes for fuel for 10 bikes. This includes smokes and bathroom breaks. It's a fuel stop NOT lunch, NOT a party. Stop, gas up, and go!
 - iv. Get fuel in riding order then get your bike out of the way. Keep pumps running and pay all at once, when possible.
 - v. Be ready to leave together.
 - f. Food
 - v. Fuel up first so you are ready to go. It's a run, NOT a party.
 - vi. Maximum time = one hour. Get your food and eat. It's a run, NOT a party.
 - vii. Do NOT get drunk, nor try to run off with the wait-staff. Two beers, MAX.
 - viii. Do NOT take a 30-minute bathroom break. Take care of business and leave.
 - g. Breakdown with a run truck
 - v. No one stops except the bike breaking down and the run truck. Everyone else, except the run truck, keeps going.
 - vi. If at all possible, if you breakdown, flash your lights, honk your horn. Let your riding partner know that you are having problems.
 - vii. SAFELY, pull over; make sure you don't take someone else down. BE CAREFUL.
 - viii. Don't sit there. Load up your bike and get back on the road. Stay with your bike.
 - ix. If possible, work on your bike in the back of truck while you are traveling. You may be able to unload and ride at the next stop.
 - x. If the bike cannot be fixed, make room for another breakdown, just in case you are not alone.
 - xi. Run truck needs to catch up with the pack.
 - h. Breakdown without a run truck
 - v. Breakdown bike and riding partner pull over together. Flash lights, honk horns. Let everyone know you are having problems.
 - vi. EVERYONE pulls over together. Stay ready to go.
 - vii. When the problem is found, riding partner notifies run leader and explains the problem, a.s.a.p.
 - viii. If the problem is minor, fix it quickly; 5-10 minutes
 - ix. If the problem is major, riding partner always stays with broken bike. Everyone else proceed to the next



stop and make arrangements.

- e. Law Enforcement
 - v. Only rear two bikes stop, if possible. Law Enforcement will let you know.
 - vi. If everyone has to stop, kill the bikes, but do NOT get off. Be ready for anything.
 - vii. The run truck does NOT stop, unless absolutely necessary. The run truck continues to the next scheduled stop and awaits information.
 - viii. EVERYONE, BE POLITE! It only takes one "asshole" to land everyone in jail. Yes Sir, No Sir, and Thank You Sir go a long way.

- x. If someone goes to jail, say goodbye and keep going. Make necessary arrangements at the next stop.
- f. Crashes
 - i. EVERYONE pull over and shut down. Be careful!
 - ii. Do what is necessary for anyone who is hurt.
 - iii. Send for assistance immediately – police, ambulance, etc.
 - iv. If need be, transport any injured in the run truck. Be careful!
 - v. Get moving! As soon as possible, send someone to get information on the injured. Then wait and pray.
